


PSHE & Citizenship Policy

Rationale

PSHE education makes a major contribution to schools' statutory responsibilities to provide a curriculum that is broadly based, balanced and meets the needs of all pupils. Under section 78 of the Education Act 2002 and the Academies Act 2010 such a curriculum must:

- *promote the spiritual, moral, cultural, mental and physical development of pupils at the school and of society;*
- *prepare pupils at the school for the opportunities, responsibilities and experiences of later life.*

Maintained schools also have statutory duties to:

- *promote children and young people's wellbeing (Wellbeing is defined in the Children Act 2004 as the promotion of physical and mental health; emotional wellbeing; social and economic wellbeing; education, training and recreation; recognition of the contribution made by children to society; and protection from harm and neglect.)*
- *promote community cohesion (Education and Inspections Act 2006; Education Act 2002)*

In addition, the *Relationships Education, Relationships and Sex Education and Health Education (England) Regulations 2019*, made under sections 34 and 35 of the *Children and Social Work Act 2017*, makes Relationships Education compulsory for all pupils receiving primary education. Health Education is also compulsory in all schools except independent schools.

Godwin Primary School recognises the importance of PSHE in promoting healthy lifestyles, managing feelings, building positive relationships, promoting positive behaviour, mutual respect and self-awareness. The school ethos is based upon cooperation and respect and informs all areas of school life.



This policy is part of our commitment to pupil health and well-being and is part of a whole-school approach, along with other policies, including: Anti-Bullying, Relationship & Sex Education, Drugs, Alcohol & Tobacco Education, Safeguarding, ICT, RE, Science, Safety Week, SEAL and a commitment to the London Healthy Schools programme.

Aims of PSHE & Citizenship in Godwin Primary School

To help pupils:

- Recognise how their own choices and behaviour can affect local, national or global issues and political and social institutions and communities
- Instil the basic rules, skills and importance of keeping clean, healthy and safe
- Articulate feelings, views, needs and rights and recognise those of others
- Take responsibility for themselves and their environment
- Develop social skills such as sharing, taking turns, playing, helping others, resolving conflict, as well as recognising, defining and resisting bullying
- Consider the consequences of their words/actions on others, recognising that bullying, including cyber-bullying, is wrong

PSHE & Citizenship at Godwin Primary School

PSHE & Citizenship is delivered through discrete lessons, covering national statutory requirements for Relationships Education, Health Education and the PSHE Association's Programme of Study. It may also be taught on a cross-curricular basis at the school's discretion. Whole school approaches also contribute, including assemblies, school council, charity events, Safety Week, colour teams, School Travel Plan and the School Council amongst many others. Social and emotional aspects of learning, which often link to PSHE, are also taught through the school's RE and PSHE provision, with targeted interventions supporting those most in need. Drugs, Alcohol and Tobacco Education (DATE) and Relationships & Sex Education (RSE) are a valued part of PSHE and have their own policies and guidelines.

Methodology and Resources

Teachers timetable a minimum of half an hour per week for PSHE. A scheme of work provides objectives and activities for each year group. Teachers may adapt lessons based upon the needs of the learners, but key ideas/objectives must be covered and included on weekly plans. The class teacher should also adapt lessons for vulnerable and SEN children, as well the religious and cultural beliefs of individuals and their families.

PSHE & Citizenship shares the features of any well-taught lesson within the school. A wide range of resources assists with the teaching of PSHE & Citizenship including books, DVDs, videos, props, games and posters. Staff should inform the PSHE & Citizenship coordinator if they require specific resources that are not available in school. A PSHE & Citizenship budget is provided to purchase such items.

External contributors are invited if they enhance provision, for example: School Nurse, Public Health Promotions Officer and religious leaders. The teacher still has overall responsibility for the lesson and should remain present to maintain discipline and devise follow-up work. Beforehand, agree clear learning outcomes and content. External contributors should be competent facilitators, fully aware of their role and responsibilities within the lesson and in the context of the school's values and policies e.g. disclosure, confidentiality, child protection etc.

Staff should also make sure that they are familiar with the correct school procedures regarding disclosure, confidentiality and child protection. Any concerns should be raised with the appropriate members of staff.

Staff Training

Those involved in teaching PSHE & Citizenship have opportunities to develop skills, knowledge and confidence their CPD. Such opportunities include: team teaching, peer coaching, observations, training courses and classroom support.

Assessment

Children should be asked to share their level of understanding; the most effective teaching techniques and what they believe will help them further as units of work progress. Summative assessment may also take place in the form of more formal activities, however assessment may also include:

- Self-assessment – diaries, check lists, portfolios
- Peer-group assessment – discussion, feedback, pupil reflection
- Teacher assessment – observations, debates, discussions, written work, drama, worksheets, quizzes or tests.

Written work should be recorded in pupils' writing books and marked in line with the Feedback Policy.

Monitoring and Evaluation

The PSHE & Citizenship coordinator is responsible for the overall monitoring and evaluation of the PSHE & Citizenship programme. Responsibilities include, as appropriate: lesson observations with feedback to teachers; sampling pupils' work; oral feedback from staff, parents, governors and pupils; monitoring planning; discussions in staff meetings/INSET sessions/subject team meetings; questionnaires.
